- **Core IP Value:** The *Lineage* IP is a cash cow with an incredibly loyal, high-spending player base in Asia. The company's expertise lies in building and operating complex, long-lasting virtual worlds.
- **Upcoming Pipeline:** NCSOFT is investing in sequels to established IPs like *AION 2* while also exploring non-MMO genres to diversify its portfolio and appeal to a broader, global audience.
- **Investor's Note:** NCSOFT is a value play. The stock's future performance hinges on its ability to prove it can launch a new global hit and reduce its reliance on the aging *Lineage* franchise.

Netmarble & Kakao Games - The Mobile Challengers

- **Netmarble (251270:KRX):** Netmarble's strength lies in its skill at developing high-quality mobile games based on globally famous IPs (e.g., *Marvel*, *Seven Deadly Sins*). However, its reliance on licensed IPs means it pays significant royalties, which can impact margins.
 - **Kakao Games (293490:KRX):** Kakao Games leverages the massive Kakao messaging platform for unparalleled user acquisition within South Korea. Its success with *Odin: Valhalla Rising* shows its strength in publishing, though it is now working to build its in-house development capabilities to compete on a global scale.

Part 3: Checklist for Trading Korean Stocks from the US

This step-by-step guide walks you through the entire process of setting up an account to trade on the Korea Exchange (KRX).

✔ Step 1: Choose the Right Broker

- Research US-based brokers that offer international trading access. The most common choices are **Interactive Brokers (IBKR)** and **Fidelity**.
- Compare their commission structures, currency conversion fees, and platform usability.

✔ Step 2: Open and Enable Your Account

- Complete the standard brokerage account application.
- During the process, you must specifically apply for **international trading permissions**. This often involves acknowledging you understand the risks.
- You will need to submit identity verification documents (e.g., passport, driver's license).

✔ Step 3: Fund and Convert Currency

- Fund your account with USD from your US bank account.
- Before you can trade, you must **convert your USD to South Korean Won (KRW)** within the brokerage platform. Pay close attention to the exchange rate and any conversion fees.

✔ Step 4: Place Your First Trade

- **Use the Ticker Code:** Korean stocks use a 6-digit numerical code, not a letter-based ticker. For example, Krafton's ticker is **259960**.
- **Specify the Exchange:** Ensure your order is routed to the **KRX (Korea Exchange)**.
- **Use a Limit Order:** It is highly recommended to use a "Limit Order" to specify the exact price you are willing to pay, rather than a "Market Order" which buys at the current price.
- **Mind the Time Zone:** The KRX is open from 9:00 AM to 3:30 PM KST, which corresponds to evening hours in the United States.

✔ Final Check: Taxes

- Ensure you have electronically signed **Form W-8BEN** with your broker. This form certifies your status as a foreign investor and is necessary to benefit from the US-South Korea tax treaty, which can reduce the tax withheld on your dividends.
